- The applicant (or "we" or "our") hereby authorizes you to obtain credit reports or other information as may be deemed necessary in connection with the establishment and maintenance of a credit account or for any other direct business requirements.
- In the event of default in payment, and our account is placed with a collection agency or lawyer, we agree to pay all costs of collection-with legal fees being calculated as an amount equal to 25% of such unpaid balance, or the maximum amount permitted by law if less than 25%).
- Shortage or damage claims must be made with transportation company.
- Products are warranted by the manufacturer only and not by United Refrigeration.
- You reserve the right to cancel this credit at any time with prior notice to the applicant.
- Without limiting any other rights which United Refrigeration may have, as security for the payment of all amounts owing by the applicant to United Refrigeration from time to time, the applicant hereby grants a security interest to United Refrigeration in the applicant's right, title and interest in and to all goods acquired by the applicant from United Refrigeration or its related entities together with all accessions thereto and all replacements or proceeds thereof.
